Kids' Rights meets the four hour requirement of the July 1, 2006 Illinois Supreme Court mandate for separating/divorcing parents with minor children.

Dina Coates Koebler, Executive Director of The Parent Place, obtained her certification in Mediation through the University of Wisconsin at Madison.

Her BA in early childhood education compliments her career as a child advocate. She has over 400 hours of domestic violence training and certification in mediation and domestic violence. She specializes in mediation focused on child placement and welfare related issues.

The Parent Place offers mediation at the rate of \$150 per hour. The length of the session is 1.5 hours. Each party is responsible for half of required payment per session (due at time of service.)

The Parent Place offers this service to separating/divorcing parents with minor children.

Each one hour customized session addresses each parent's specific challenges:

- Transitioning between houses
- Appropriate expectations in child development
- Alternatives to Corporal punishment
- Non-combative co-parenting communication
- Integrating child into parent's new relationships
- Anger management coping skills
