2020 KEY DATE SYSTEM

Enclosed please find:

1. Key dates for all agencies for use at both 9:00 am & 1:30 p.m. **with the exception of Tuesdays. Tuesday hearings will be held at 9:00am only.**
2. First appearance dates assigned to various municipalities and other state agencies.

Please note the following regarding the 2020 Key Date System:


1. Police officers are required to be available on their key dates for first appearances on all traffic cases. Police officers are not however required to appear at the first appearance dates for non-traffic misdemeanor cases.
2. All traffic and misdemeanor trials will be specially scheduled by the Courts.
 - a. When a case has been set for trial, the police officer will receive a subpoena from the State's Attorney's Office indicating the trial date and time.
3. If, for whatever reason, a police officer does not have an available key date for a first appearance on any traffic citation within the 14-60 day rule, the officer must set the first appearance on any date assigned to his, or a similar police agency within the 14-60 day rule.
4. Three days prior to the key date, agencies may obtain a list of traffic cases still scheduled from the Circuit Clerk's Office at www.sangamoncountycircuitclerk.org.
